
Innovation doesn't just mean technology. Walmart was one of the earliest holdings in the fund.

The global innovators universe contains about 1000 companies that the fund management team identifies as innovative. They then select approximately 30 companies from this universe to make up the portfolio.



INNOVATION IS MORE THAN A TREND (BUT IT IS TRENDING)

The graph below shows the Google searches for the keyword "Innovation" from January 1, 2004 to December 1, 2023. Clearly, interest in innovation has increased - but we were ahead of the curve. As it stands, innovation has reached peak popularity. We're not saying that we made innovation popular, but you can draw your own conclusions.



Google trends wouldn't let us go back further than 2004.

Numbers represent search interest relative to the highest point on the chart for the given region and time. A value of 100 is the peak popularity for the term. A value of 50 means that the term is half as popular. A score of 0 means that there was not enough data for this term.
